



## Requirements for Club Recognition

NAPHA realizes that Clubs are unique depending on the interests of members. Some tend to be social in nature while others may be geared toward shows – or trail riding or seminars, etc. What is important is that a Club is genuinely a “club” with members and member benefits. These are the Requirements for NAPHA Club Recognition:

**Initial Requirement** – Signing the basic Memorandum of Understanding.

### **Annual Requirements-**

1. The Club must host one activity or offer one benefit (such as a Newsletter, Trail Ride, Show, Open House, Social Gathering...) each quarter (i.e. 4x per year).
2. The Club must have a minimum of ten (10) members and send a complete list of those members (names, addresses, phone#s) to NAPHA annually.
3. The Club must complete the Memorandum of Understanding and Annual Club Reporting form and return it to NAPHA each year.
4. The Club must put NAPHA on its membership list and send all Club mailings including Newsletters and copies of Club Meeting Minutes.

### ***APPROVED PERUVIAN HORSE CLUBS***

The presidents of Approved Clubs may participate in the Regional Advisory Council meetings if they wish. Approved Clubs must meet all the requirements listed above, have ten (10) NAPHA members on their membership roll and their president must be a member of NAPHA.
