IMPORTANT INFORMATION ON HOW YOUR HORSE IS REGISTERED  
PLEASE READ !

Dear Owner:

NAPHA maintains its STUD BOOK and records on computer for the convenience of storing and retrieving data in as expedient and accurate a manner as possible. The advantages this computerization (which was completed in 1980) has offered our members and all owners is remarkable. We hope that you, too, will find the available reports and information of value.

From past experience we realize that the computer has made for much more accurate records. However, it makes it more difficult for us to accommodate in some areas and that is why we would like to explain how it works and ask for your cooperation.

Very often, owners will register their horses under a variety of names - e.g.:

Bob Smith Mary Smith

Bob and Mary Smith Bob &/or Mary Smith

Mr. and Mrs. Robert Smith Robert D. Smith

In most instances, we have found that Mr. and Mrs. Smith would prefer to have ALL their horses registered in the same manner and are happy to have the uniformity that the computer offers. In these instances, all we need to know is exactly how we are to register all of a particular "entity's" horses. The computer will do the rest! We realize that in other circumstances (such as partnerships, etc.), differing "entities" must be recorded although they may include some of the same people recorded under another "entity." This can be done by the computer; however, we wish to eliminate all **unnecessary** confusion and the addition of as many extra entities as possible.

One additional note: if you register your horses to Bob &/or Mary Smith, NAPHA will only require **ONE** signature for registration purposes - with the exception being that if the horse is to be transferred to one of the parties, the other will be required to sign off. If a horse is registered to Bob & Mary Smith - then **BOTH** Bob and Mary will need to sign all paperwork - transfers, registration of foals, stallion reports, etc.

Therefore, we are enclosing a form for you and request that you return it **EXACTLY** as you wish your horses to be registered. If you decide to join NAPHA, your membership will be recorded in the same manner. All horses coming in for registration or transfer will then **automatically** be listed in this manner. If you must, for some special reason, register a horse differently, you have the option of either paying the "non-member" fee or taking out a separate membership for each "entity" under which horses are registered. (Our policy on membership automatically confers membership on an "entity" where **each and every** individual in that entity has a separate, current membership. For example: Jane Adams and John Smith each have individual memberships in their name. They have a partnership of Jane Adams & John Smith. NAPHA will consider that entity a member for the purpose of registration fees and show points. However, if John Smith allows his own, individual membership to lapse, then the partnership will also no longer be considered a member.) We hope that this will actually simplify the registration process for you. It has proven to be very helpful in the past and has speeded up the registration and transfer of horses for our members.
