

## INSTRUCTIONS FOR THE REGISTRATION OF AN IMPORTED HORSE FROM PERU

---

1. Owner or designated, recorded Agent should complete the top third on the front of the registration application and sign where it says "owner of the mare at the time of foaling", crossing out the "of mare at the time of foaling" part.
2. Complete the markings section on the back of the application.
3. Return to the NAPHA office with the following:
  - a) Copies of **BOTH** sides of the horse's ANCP CPP (Peruvian) registration papers.
  - b) If the horse was registered in Peru after May of 1982 (see "Fecha de Registro in the lower left corner of the ANCP CPP papers,) NAPHA requires documentation to verify that the horse qualifies for a closed stud book. This verification is made via copies of the sire's and dam's ANCP CPP certificates of registration (or grandsire's and granddam's and further back until pedigree shows registration prior to 1982.) If the horse does not qualify, it will be registered provisionally.
  - c) Photographs: (1) Full profile/side view of right side; (2) Full profile/side view of left side; (3) Full face/frontal view; and (4) Full rear view. All four legs must be seen from both sides; markings on face must be visible. All photos should include **all parts** of the animal available in that view (ears to hooves or nose to tail inclusive) and be unobstructed by any other object or animal. Additional photos should be submitted to verify markings not seen in the standard four photos (i.e., white on belly, markings under mane area, etc). Label each photo with first choice of name and owner's name on the back. Photos must be a minimum of 3" x 5" and a maximum of 4 x 6". We accept digital photos if printed on quality photographic paper. We do not accept color copy photos.



- d) A copy of USDA - Veterinarian's Report of Inspection for Importation. Put the date of importation on the front of the registration application and label it as such.
- e) If the horse being registered is a foal imported in utero, the Breeder and Service Certificates must be submitted on the NAPHA registration application.
- f) DNA type results (if not done by UC Davis add \$10 member or \$ 15 non member). Or the appropriate fee to DNA type the applicant horse (\$ 55 member or \$ 75 non member.)
- g) If the horse was registered in Peru after June 1, 2007, owner must provide NAPHA with a copy of the parental verification and a copy of the DNA marker report along with the DNA marker report for the sire and dam, and all fees as stated on the Fee Schedule.
- h) Registration fee of an imported horse is \$125 member or \$600 non members.

Please note: ALL ungelded males registered or transferred to NAPHA will be registered with a "T" number indicating that they have not yet been registered for breeding purposes. These horses will be subject to NAPHA rules regarding registration of stallions for breeding (those rules require DNA typing, NAPHA's veterinarian's statement that the horse has two normal, descended testicles and a fee of \$100 member or \$150 non member.)
