## STALLION REPORT

The Registrar shall send out blank stallion report forms to owners of NAPHA registered stallions no later than November 15th of each year. Stallion Report forms must be returned to NAPHA no later than January 10th. along with \$55 member or \$65 non member fee. Between January 10th and March 1st, reports will be accepted if accompanied by a \$105 member or \$210 non member fee. After March 1st, reports will only be accepted with justifiable cause for the delay on the approval of the Board of Directors and with a fine of \$500. Owners of stallions are responsible for notifying the Registry of any change of address so that reports can be mailed.

All owners of pure-bred stallions which have serviced pure-bred mares during the calendar year shall submit a stallion report form to the NAPHA office at the end of the breeding season as outlined above.

There is a \$30 member or \$ 60 non member fee for any stallion report filed which is incomplete (does not have full name, registration #, type of breeding, owner, etc.)

- Every stallion owner must report <u>ALL</u> purebred Peruvian mares bred to his stallion(s) during the year whether such mares are owned by the stallion owner or by another person. If mares other than pure-bred Peruvians have been bred, they should also be listed in order for part-bred foals to be eligible for registration. (Draw a solid line after listing all pure-bred Peruvians, then list all other mares bred.)
- 2) A separate form must be filed for each stallion each year.
- 3) **ALL** pure-bred Peruvian mares bred (not just those confirmed in foal) must be listed with the name(s) of the owners of the mares and **ALL** dates of service.
- 4) This report must be signed by the owner of the stallion. In addition, the report may be signed also by the owner's manager or authorized agent. In the case of a lease stallion, the lessee and the stallion owner should sign this report.
- 5) If a stallion stands at more than one location during the calendar year, a separate report must be submitted for his breeding activities at each location.
- 6) If the stallion owner wishes an easy way to assure that his report has been received by the Registry, he may send a self-addressed, <u>stamped</u> envelope along with the report. The office will stamp the report with the date of receipt and return a copy to the owner in the SASE.
- 7) The type of breeding section must be completed for this report to be accepted. (See guide below.)

For the purposes of this report and the Service Certificate required to register a foal the following types of breeding are described as noted:

NATURAL SERVICE - "in hand" breeding where the stallion and mare are under the control of handlers.

**PASTURE BREEDING** - where the stallion and mare(s) are turned out together. The stallion owner need not list the actual dates of breeding - only the dates of exposure (e.g.: March 13 through September 3.)

AI - Artificial Insemination on premises (e.g.: the stallion and mare are at the same farm and the mare is bred via AI = the semen is not "shipped") SHIPPED FRESH, SEMEN - where shipped, fresh (not frozen) semen is used to AI a mare - LISTDATE(S) OF COLLECTION/SHIPMENT FROZEN SEMEN - where frozen semen is used (whether "shipped" to a different location or not) - LIST DATE(S) OF COLLECTION/SHIPMENT EMBRYO TRANSFER - this section should be checked in addition to the actual type of breeding if it was done to produce an embryo for transfer
