

**INSTRUCTIONS FOR THE TRANSFER OF A HORSE
FROM THE PHAC - PERUVIAN HORSE ASSOCIATION of CANADA**

Please Note: This does NOT mean that the horse will no longer be registered with the PHAC - only that the normally required breeding certificates, stallion reports, etc. will be waived on the presumption that they have been properly filed with the original registry.

1. Complete the top third on the front of the registration application and sign where it says "owner of the mare at the time of foaling" - striking out the "of mare at the time of foaling" part. (Except for signature, please type or print in ink.)
2. Complete the markings section on the back of the application. Be sure to do so with the horse in front of you to insure accurate markings for identification.
3. Return to NAPHA with:
 - a) Copies of **both** sides of the PHAC registration papers (also ANCPCPP &/or any other registration papers the horse may have) plus any DNA typing &/or Parental Verification done.
 - b) If the horse was registered in Peru after May of 1982 (see "Fecha de Registro in the lower left corner of the ANCPCPP papers,) NAPHA requires documentation to verify that the horse qualifies for a closed stud book. This verification is made via copies of the sire's and dam's ANCPCPP certificates of registration (or grandsire's and granddam's and further back until pedigree shows registration prior to 1982.)
 - c) Photographs: (1) Full profile/side view of right side; (2) Full profile/side view of left side; (3) Full face/frontal view; and (4) Full rear view. All four legs must be seen from both sides; markings on face must be visible. All photos should include **all parts** of the animal available in that view (ears to hooves or nose to tail inclusive) and be unobstructed by any other object or animal. Additional photos should be submitted to verify markings not seen in the standard four photos (i.e., white on belly, markings under mane area, etc). Label each photo with first choice of name and owner's name on the back. Photos must be a minimum of 3" x 5" and a maximum of 4 x 6". We accept digital photos if printed on quality photographic paper. We do not accept color copy photos.



- d) If the horse was registered in the PHAC after January 1, 2000, verification of parentage by DNA is required for transfer. Please contact the PHAC for a copy of the DNA and Parental Verification results.
- e) DNA typing results (if not done by UC Davis, add \$ 10) or the appropriate fee to DNA type the applicant horse (\$55 member or \$ 75 non member).
- f) Fee: \$ 45 member fee or \$ 90 non-member fee

Please note: ALL ungelded males registered or transferred to the NAPHA will be registered with a "T" number indicating that they have not yet been registered for breeding purposes. These horses will be subject to NAPHA rules regarding registration of stallions for breeding, those rules require DNA typing, a veterinarian's statement that the horse has two normal, descended testicles and a fee.
