# NAPHA Advisory Council Meeting 2/21/24

### **NAPHA President Briefing:**

Paul Opdyke is the newly elected NAPHA President. For the last couple of weeks, he has been talking to people and getting a "feel" for how members are relating to NAPHA. He has been "mending a bunch of fences" between NAPHA and its members. He has been told that members don't feel like they are being heard by NAPHA and Paul said that he is listening. Paul wants to do business more openly and welcomes and needs engagement from members.

Paul gave us a little sneak peek into the upcoming website improvement project. This will not be an incremental improvement approach. There has been a lot of communication about the lack of improvements on the website so NAPHA is engaging in a full-blown endeavor to correct the issues. The goal of the website is to have a better appearance and improved functionality. The timetable for these improvements is between 4-6 months.

Paul was specific with the Advisory Council's expectations and the vision for the council. He wants the Council to address the fundamental issue of attracting and keeping the members. Work on getting more people into the breed. Actions happen on the ground at the regional level and that is why it is so important for regional areas to have a list of current and former members, along with a list of people who own Peruvians but are not members. We need to keep everyone informed and involved the best we can.

Look at the strategies of other horse clubs and see how they are attracting and keeping members. What are the current clubs doing right? An example is the Northern Lights Peruvian Horse Club. They have a very large and active member base. How are they getting their members to stay active? How do we attract new exhibitors/riders as they are the future of the Peruvian breed?

NAPHA has 203 active members. Mike Powers is to send that list to all Advisory Council members. An important part of making the clubs grow and have active members again, is to contact people who own Peruvians but are not current members of a club. How do we get these people to reconnect with a club? More activities?

Paul also mentioned the Amateur Performance classes being split into the two categories of Level 1 and Level 2. This will hopefully encourage more riders to show in performance.
